

The ASE index Quarterly review

Mr. Mazen Wathaifi the Chief Executive Officer of the Amman Stock Exchange (ASE) said that the ASE has conducted the periodic quarterly review of the ASE indices constituents in purpose of ensuring that these indices reflect the market performance and the trading activity of the listed companies. By this rebalancing, the activity of listed companies in regard to trading during the last quarter has been reviewed. After that, the ASE has conducted its screening process for all listed companies based on the criteria used by the ASE represented by full market capitalization of the companies and the number of trading days during last quarter.

Mr. Wathaifi added that as a result of this review, 6 companies have been excluded from the general index sample ASEGI and other 5 companies have been added. The companies that have been excluded from the index sample were: Jordan International Investment Co., Zara Investment Holding, Specialized Investment Compounds, Amwaj Properties, Union Tobacco & Cigarette Industries, and Sheba Renewable Energy.

The companies that have been added to the index sample were: Al-Quds Ready Mix , The Jordan Worsteds Mills, Arab Company for Investment Projects, Arab International Hotels, and Jordan National Shipping Lines.

As part of the process, the ASE calculated the free float for all listed companies on the ASE based on the data received from the Securities Depository Center. This review also includes the reduction of the weights for some companies to maintain the 10% cap that applied to index constituents.

Regarding the general index ASEGI, Mr. Wathaifi clarified that the full market capitalization of the index constituents represents 91.0% of the total market capitalization of the companies listed on the ASE. The free float market capitalization of the index constituents represents 93.8% of the total free float market capitalization of the listed companies on the ASE.

As for the ASE20 and ASETR indices the full market capitalization of the index constituents represents 83.7% of the total market capitalization of the companies listed on the ASE, while the free float market capitalization of these companies represents 87.2% of the total free float market capitalization of the ASE listed companies.
