

## Article (41)

The Stock Exchange's funds shall be constituted of the following:

- A. Subscription and annual membership fees collected from its members, as well as commissions, charges, allowances and fines stipulated for in its regulations.
- B. Earnings on the Stock Exchange's property and money, and sale proceeds of its assets.
- C. Gifts, donations and assistance approved by the Board.
